TREBINJE ENERGY SUMMIT - GENERAL CONDITIONS OF PARTICIPATION

1. The organizer of the Summit of Energy, Energy Efficiency and Renewable Energy Sources "TREBINJE SET" is SET doo Trebinje (hereinafter the Organizer).
2. The participant registers his / her participation in the Summit by registering online on the website www.setrebinje.com. By sending an online application to the organizer's e-mail, the participant declares that he agrees with the General Terms and Conditions and accepts them.
3. After receiving the online application, the organizer issues an invoice for the payment of the required registration fee, whereby the organizer of the Summit confirms the place reservation to the participant and enters into a binding relationship of fulfilling all invoiced orders to the participant. The participant is obliged to pay the required registration fee according to the currency deadline indicated on the invoices.
4. The registered participant may withdraw from participation under certain conditions, as follows:
 - 30 days before the beginning of the Summit, in which case the registration fee will be refunded,
 - 15 days before the start of the Summit, in which case 50% of the registration fee will be refunded
 - Cancellation less than 15 days before the beginning of the Summit is not possible, and the organizer will keep the entire amount of payment, or issue an invoice to participants for other costs incurred.
